



City of Boston Resident Parking Permit

Boston's Resident Permit Parking Program is an initiative designed to give residents a better chance of finding an on-street parking space in their neighborhood. Many of the parking spaces on Boston's residential streets are regulated as "Resident Parking Only." A smaller number of parking spaces on these same streets are posted as "Visitor Parking" areas for the guests of neighborhoods residents. Residents who live in areas where parking is regulated for residents only must apply for a Resident Parking Permit to avoid receiving parking tickets.

All outstanding City of Boston parking tickets must be paid before applying for or renewing a resident parking permit.

Permits are distributed by the Office of the Parking Clerk, Room 224, City Hall. Residents, or their representatives, must apply in person Monday through Friday, between the hours of 9:00 a.m. and 4:30 p.m.

Temporary Resident Parking Permits

The Office of the Parking Clerk will grant a temporary permit to residents with a current Resident Parking Permit for rental cars only. In the event that you have to temporarily use a rental car, fax your rental agreement to the Clerk's Office for a temporary permit.

Obtaining a Resident Parking Permit

For your convenience we have attached a City of Boston Resident Parking Permit Application and Affidavit which you may fill out and bring to City Hall. You may also download the necessary parking permit from the City of Boston's website at <http://www.cityofboston.gov/parking/residentparking/>. In addition to the application form, the following two pieces of information must be presented at the Office of the Parking Clerk when applying for a permit:

1. A valid Massachusetts automobile registration showing your car registered and principally garaged in your name from your current Boston address.
2. One of the following proofs of residency bearing your name and Boston address. The proof of residency must be current - postmarked within the past 30 days.
 - Gas, Electric or Telephone Bill
 - Cable Television Bill
 - Monthly Bank Statement (excluding mortgage)
 - Credit Card Bill
 - Water and Sewer Bill
